### ■ Introduction

Franklin Pierce Law Center is known throughout the world as an innovative leader in legal education, providing its students with the skills to lead and serve, and to meet the emerging needs of a global society. Pierce Law emphasizes individually tailored legal programs and a broad range of learning settings, including lectures and seminars, real-client clinics, independent study, and externships in law firms, in courts, and in private and public agencies. In addition, we promote a community spirit of caring and compassion, with a close working relationship between students and faculty. Self-reliant students who know their own strengths and objectives thrive at Pierce Law and find the focus on personal pride and responsibility more motivating than fear or competition.

Pierce Law is one of the smallest private law schools in the United States. Each entering class numbers approximately 150 students, allowing for a 17 to 1 student-teacher ratio. Classes are small, especially after the first year. Seventy-five of the 109 elective courses enroll 35 or fewer students.

Located in New Hampshire's capital city of Concord (45,000 population), Pierce Law is ideally situated one hour from Boston, the Atlantic seacoast, the state's Lakes Region, and the White Mountains.

### ■ Special Programs

- **Intellectual Property**—The internationally recognized intellectual and industrial property specialization (patents, licensing, technology transfer, trade secrets, trademarks, cyberlaw, and copyrights) is supported by 12 full-time faculty members, all intellectual property lawyers. Training includes learning to advise clients regarding intellectual property protection, infringement, and technology transfer. Students with technical backgrounds may focus on patent law, many passing the patent bar prior to graduation. Other intellectual property areas do not require a technical background.
- **Commerce and Technology Law**—The business curriculum prepares students for traditional types of practice and brings new opportunities for students choosing to confront the legal issues involving electronic commerce. The business and e-commerce curriculum also integrates well with the intellectual property curriculum, particularly for students interested in business and legal innovations associated with the Internet.
- **Social Justice Institute**—This hands-on professional training program prepares students for public interest law in private practice, governmental service, social policy advocacy, and criminal practice. Clinic students provide legal assistance to clients in cases involving divorce, neglect and abuse of children, juvenile issues, social security, personal bankruptcy, consumer issues, and housing problems. In addition, students have the opportunity to assist in projects with the Institute for Health, Law, and Ethics.
- **Criminal Law**—As part of our Social Justice Institute, our Criminal Law curriculum offers courses, individual mentoring, clinics, and externships to prepare students for careers in prosecution or defense. Criminal Practice Clinic

students represent clients charged with misdemeanor and juvenile offenses at the district court level. In the Appellate Defender Program, students prepare briefs for the New Hampshire Supreme Court in criminal cases. Externship opportunities are available in prosecutorial positions at the local, state, and federal level and in defense positions with law firms and governmental agencies.

### ■ International Summer Institutes in China and Ireland

- The Intellectual Property Summer Institute at Tsinghua University in Beijing offers an overview of China's patent, copyright, and trademark laws as well as an introduction to some of the major international instruments and institutions regulating international trade and intellectual property.
- The eLaw Summer Institute at University College Cork, Ireland, focuses on law and emerging policy of the Information Age.

### ■ Academic Opportunities

The *Webster Scholar Program* is a comprehensive, practice-based honors program focused on making law students client-ready. Second- and third-year students complete a range of courses, demonstrate their developing professional skills and judgment, and compile a portfolio of work. Students who successfully complete the program will be certified as having passed the New Hampshire bar examination, subject to passing character and fitness requirements.

The Pierce Law *Externship Program* exchanges a full-credit semester in the classroom for a real-life experience working in an active legal position. Externs work with experienced attorneys and judges while under the close supervision of a faculty member.

### ■ Joint-degree Programs and LLM

Pierce Law offers the JD/Master of Intellectual Property, Commerce, and Technology dual degree. Summer programs enable students to earn additional credits needed to complete joint-degree programs in three years. The Master of Laws (LLM) in Intellectual Property, Commerce, and Technology is designed for law graduates who wish to examine the legally sophisticated intellectual property issues that often arise in policymaking and teaching.

### ■ Student Activities

Students prepare notes and comments for *IDEA: The Journal of Law and Technology*; *Pierce Law Review*; and *Annual Survey of New Hampshire Law*, an annual publication consisting of six articles focusing on recent New Hampshire Supreme Court opinions. Students organize and participate in a wide variety of formal organizations and informal activities and events throughout the year.

### ■ Career Services

The Career Services Office works with students and alumni to find the best match to meet their skills and interests in

changing legal markets. The office provides extensive individual counseling and guidance; brings attorneys to campus to provide first-hand information about the practice of law; advises students of all resources through weekly publications and job boards; coordinates the efforts of faculty, staff, and student groups to provide information about opportunities to gain experience; and conducts outreach to employers. More than 75 percent of our graduates secure positions outside New Hampshire. Over 90 percent of our graduates are employed within six months after graduation.

## ■ Admission
